- Please do not drop off your child any earlier than 10:20 (10:30 start) or 10:50 (11:00 start). Please be prompt when picking up your child.
- Drop off your child at the Bridgehampton Playground. Most activities will take place at the clubhouse / field.
- Your child will need to bring their own bag lunch and a water bottle each day. We will have a large cooler to keep food and drinks cold.
- Please have your child dress for activity. This includes sneakers. Also have them bring their swimsuit and a towel as we will swim each day.
- Please have your child apply (and bring extra) sunscreen and hand sanitizer. Hats and sunglasses are also encouraged.
- We will make every attempt to have camp each day. If a day is cancelled for anything other than severe weather, the day will be refunded.
- With respect to both our counselors, and lifeguards. If a camper is talked to for unsafe behavior or breaking of the community pool rules, they will be given a warning, or possible swimming privileges being removed for the remainder of that day. If it continues it could lead to no swimming for the remainder of camp.
